Please note the following before using the Kit:

- For use by public and private safety professionals only. Not for consumer use.
- This product is for FIELD USE ONLY and is not intended for diagnostic or laboratory use.
- Confirmatory testing by bacterial culture, DNA testing and/or antibody tests, is required before a definitive assessment can be made as to whether a particular pathogen or toxin is present.
- Some safe substances—such as baker's yeast—will test positive with the BioCheck Kit. Thus, confirmatory testing is always required if positive.
- It is intended for the screening of suspected weapons of mass destruction (WMDs) where quantities of the active agent will be present in visible amounts. It is not designed for environmental sampling or testing for individual poisons.
- This product is designed to measure visible powders. The biohazardous material must be present in amounts of equivalent to 100 µg or more (approximately half the size of a pencil eraser).
